| What? | <p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> Social security number and assets Income and risk tolerance Account transactions and account balances <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p> |
| How? | All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons we choose to share; and whether you can limit this sharing. |

| How does Alaska Wealth Advisors protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. |
| How does Alaska Wealth Advisors collect my personal information? | We collect your personal information, for example, when you: Complete an investment advisory agreement or other forms Open an account or seek advice about your investments Make a wire transfer or direct us to buy securities |
| Why can't I limit all sharing? | Federal Law gives you the right to limit only: Sharing for affiliates' everyday business purposes –information about your creditworthiness Affiliates from using your information to market to you Sharing for non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing. |
| What happens when I limit sharing for a partnership interest I hold jointly with someone else? | Your choices apply to all parties unless you inform Alaska Wealth Advisors otherwise in writing. |
